This Privacy Policy explains how DentEdge.net (“DentEdge,” “we,” “us”) collects, uses, shares, and protects information when you use our website and services (the “Service”). By using the Service, you agree to this Privacy Policy.

1) Information we collect

1.1 Information you provide

- Account information: name, email, password (stored in hashed form).
- Study and usage information: exam preferences, progress data, quiz attempts, scores, and similar learning analytics.
- Support communications: messages you send us and any information you include in them.
- Payment/verification information (manual subscriptions): information needed to confirm your payment (e.g., transaction reference/receipt screenshot, payer name/number). We do not require or intend to store full card numbers.

1.2 Information collected automatically

- Device and log data: IP address, browser type, device information, pages visited, timestamps, referring/exit pages.
- Cookies and similar technologies: used for login/session, security, and site functionality.

1.3 Sensitive information

DentEdge is an exam-prep service. Do not upload patient-identifying information, clinical records, or any other sensitive data.

2) How we use information

We use information to:

- Provide and operate accounts, logins, and core features.
- Deliver exam-prep content and track learning progress.
- Confirm payments and activate/renew access (manual subscription management).
- Provide customer support and respond to requests.
- Maintain security, detect fraud/abuse, and enforce our Terms.
- Improve the Service (performance, content quality, user experience).
- Communicate important notices (service changes, policy updates, security messages).

3) Cookies

DentEdge uses cookies for:

- Essential cookies: login/session and security.
- Functional cookies: remembering preferences.

You can control cookies through your browser settings. Disabling cookies may affect site functionality.

4) AI features and third-party processing (if enabled)

DentEdge may offer optional AI-assisted features (for example, generating explanations, summaries, or practice items).

- **What is shared:** If you use AI features, the text you submit (such as prompts, questions, or answers) may be transmitted to a third-party AI service provider to generate a response.
- **Why we share it:** to provide AI-generated outputs and to improve feature quality and reliability.
- **No connection/affiliation:** DentEdge is not affiliated with, endorsed by, or sponsored by the AI provider. If AI is available through a provider's free tier, that availability and limits are controlled by the provider.
- **Provider rules:** Use of AI features may also be subject to the provider's own terms and privacy practices.
- **Free feature and limits:** AI is offered as a free feature and may be disabled at any time, including if free-tier capacity/quotas are exceeded.

Do not enter confidential exam materials, patient-identifying information, or other sensitive information into AI prompts.

5) How we share information

We may share information only as needed with:

- Service providers that help us run the Service (e.g., hosting, email delivery, security tools).
- Payment-related services only to the extent necessary to confirm payments.
- AI service providers when you choose to use AI features (see Section 4).
- Legal and safety: if required by law, court order, or to protect rights, safety, and prevent fraud/abuse.

We do not sell your personal information.

6) Data retention

We keep personal information only as long as reasonably necessary for:

- Operating the Service and your account.
- Security, abuse prevention, and dispute resolution.
- Legal, accounting, or tax obligations (where applicable).

7) Security

We use reasonable administrative, technical, and organizational safeguards (e.g., HTTPS/TLS, access controls). No method of transmission or storage is 100% secure.

These Terms of Use (“Terms”) govern your access to and use of DentEdge.net (the “Service”). By accessing or using the Service, you agree to these Terms. If you do not agree, do not use the Service.

1) Educational purpose — no professional advice

DentEdge provides educational exam-preparation content only.

- DentEdge is not a substitute for professional dental/medical advice.
- Do not use DentEdge to diagnose, treat, or make clinical decisions.

2) Accounts and eligibility

- You must provide accurate information and keep your login credentials secure.
- You are responsible for all activity under your account.
- We may suspend or terminate access if we reasonably suspect fraud, abuse, or violation of these Terms.

3) Manual subscriptions, access, and payments

DentEdge access is provided on a subscription basis and may be activated or renewed manually after payment confirmation.

- No automatic renewal: unless we explicitly state otherwise, your access does not renew automatically.
- Activation: access is granted after we verify your payment.
- Renewal: you are responsible for renewing before your access expires.

Refund policy
